

**Engen: Stand a chance to win your share of R50 000 in Engen 1App vouchers.  
COMPETITION RULES**

Read these Competition rules carefully. These Competition rules (“rules”) explain your rights and duties in connection with this Competition. If you take part in this Competition and/or accept any prize, these rules will apply to you and you agree that the promoter(s) can assume that you have read and agreed to be legally bound by these Competition rules.

<b>Competition Name:</b>	Engen Competition: Stand a chance to win your share of R50 000 in Engen 1App vouchers when you fill up at any Engen fuel stations.
<b>Promoter(s) Name(s):</b>	This competition is run by FNB-eBucks, a business unit within First National Bank, a division of FirstRand Bank Limited (Registration No. 1929/001225/06 (“eBucks”)) an Authorised Financial service and Registered Credit provider, having its principal place of business at 10th Floor, FNB Place, First National Bank, Bank City, 30 Diagonal Street, Johannesburg, Gauteng, South Africa, 2000. The person responsible for conducting the promotional competition on behalf of eBucks is Bruce Gibbs a Partner Growth Manager at eBucks. In these rules we refer to the above promoter(s) as “the promoter(s)”, or “us” or “we”. We will refer to participants as “you”.
<b>How to enter?</b>	<ul style="list-style-type: none"> <li>• The competition is open to all valid FNB/RMB Private Banking account holders.</li> <li>• Pay with your qualifying FNB/RMB PB bank card, eBucks or a combination of both and stand the chance to win a R500 Engen 1App voucher.</li> <li>• Fill up at any Engen fuel stations during the campaign period.</li> <li>• 100 winners will be selected who will each win a R500 Engen 1App Vouchers</li> <li>• The draw will take place at the end of the campaign period and will be conducted by eBucks. The winner information will then be passed on to Engen to contact the winners and load their vouchers onto their profile on the Engen 1App.</li> <li>• Redemption Steps: Winners will have to download the Engen 1App to load the voucher. Once you have received the vouchers, Engen will send the voucher codes to the winners who will load them directly to the 1card via their 1wallet.</li> <li>• FNB is not responsible for any lost, corrupted or delayed entries and these will be deemed invalid.</li> </ul>
<b>The prizes</b>	<ul style="list-style-type: none"> <li>• One hundred (100) customers will win one R500 voucher each.</li> </ul>
<b>Entries open:</b>	Entries open on 16 December 2020 at 00:00am.
<b>Entries close:</b>	Entries close on 9 January 2021 at 11:59:59 pm. The promoter(s) reserve the right to extend the Competition by amending these Competition rules.
<b>Is there a limit on the number of times you can enter?</b>	There is no limit on the number of entries. Every separate purchase from Engen using your FNB/RMB PB, eBucks or a combination of both will count as an entry into the draw.
<b>Eligibility: Who qualifies to take part?</b>	This Competition is open to any legal resident of the Republic of South Africa who is a natural person, 18 years of age or older at the time of entry and is a member of the eBucks Rewards Programme. excluding the categories of people listed below who cannot take part.

<p><b>Who cannot take part?</b></p>	<p>The following persons may not take part in this Competition, will be disqualified if they do and will forfeit any prizes that may have been awarded to them:</p> <ul style="list-style-type: none"> <li>a) Any employee of the promoter(s).</li> <li>b) Any director, member, partner, agent of, or consultant of the promoter(s).</li> <li>c) Any other person who directly or indirectly controls the promoter(s).</li> <li>d) Any supplier of goods and services in connection with this Competition.</li> <li>e) The spouse, life partner, siblings, children, or parents of any of the persons named in a, b, c, or d, above</li> </ul>
<p><b>How will winner(s) be chosen?</b></p>	<p>A draw will take place during the week of 25 January 2021 to determine the winners. The random entry drawn will be checked to establish whether it meets the Competition qualifying and eligibility criteria. The random draw will be overseen by the Legal, Risk &amp; Compliance team at eBucks. The winner will be drawn from the transactional sales data for the Competition period. Should the Competition draw be postponed to another date for any reason whatsoever, the new date will be published on the FNB Website within four days of the original draw date. The random entries drawn will be checked to establish whether they meet the Competition qualifying criteria and if so that entry will be the prize winner, subject to us being able to contact such winner within 48 (forty-eight) hours of the draw taking place. If the qualifying criteria to enter the Competition are not met, a further random draw will take place until a randomly selected, valid entry meets the eligibility criteria.</p>
<p><b>How will winner(s) names be announced?</b></p>	<p>The prize winners will be announced on Engen's 1 App and on eBucks.com. If the prize winner cannot accept the prize for any reason whatsoever or cannot be reached through no fault of the Promoter, the prize will be awarded to the entrant who was drawn second.</p>
<p><b>Data Usage and Privacy Policy</b></p>	<p>Participants in the Competition understand and agree that in order to offer the Competition, we may collect and use personal information about participants. This personal information may include a participant's first name, last name, email address, mobile number and in certain instances your image. We will treat your information in total confidence and will not sell, share or rent this information to any other third parties. We may disclose information if required to do so by law or if it is required to protect the safety, rights or property of eBucks, our members, customers or the public.</p>
<p><b>General</b></p>	<p>No correspondence will be entered into regarding either this Competition or these Rules. In the unlikely event of a dispute, our decision shall be final. We reserve the right to amend, modify, cancel or withdraw any aspect of this Competition in our sole discretion at any time without notice or liability. We cannot guarantee the performance of any third party and shall not be liable for any act or default by a third party. Participants in this Competition agree that we will, subject to prevailing law, have no liability whatsoever for any injuries, losses, costs, damage or disappointment of any kind resulting in whole or in part, directly or indirectly from acceptance, misuse or use of a prize, or from participation in this Competition.
